Discussion of the June Conversation with the Board. Those that had issues and needed to be heard were heard. Finances were not a big issue, but the bathroom and the Lord's Prayer were. Those items that are brought forth that are brand new and could need collaborative efforts will be presented to our people for input and some discussion. This could be in special meetings, or during small group or ministry meetings.

Proposal for Facility Changes

Remodeling of the chapel was discussed. At present it is not accessible, used mostly for storage and is not usable for many dynamics. Removing the pews, purchasing very nice cushioned stacking chairs and putting in new flooring could create an additional flexible worship space plus offering 5 different modes of a meeting spaces. Using prepared drawings Wally brought, 5 modes of use were looked at. The monies for this remodeling would not come from the operating budget. Fine Arts is planning a fund raiser, persons could be asked to "buy a

chair" and from the sale of the pews. Jim Merk will open this discussion with an announcement this Sunday about a meeting and presentation coming up showcase all the options and plans.

Staffing Options

Pastor John, Karrie Rigaud, Lin Waid and Kathy Breazeale had a meeting to design the process of determining what is to be done with the position of Discipleship Coordinator. A Sept. 8th meeting after 2nd service has been set to gather input from parents of children and youth plus contacting adult education to survey everyone's wants and needs and levels of volunteer participation.
