# **Governing Board Application**

An application has been received. Roger and Mary will handle the interview. Roger will check with Jonathon Akyea to see if he would consider being the Congregational Delegate for interview.

#### **Finances**

Wally Loague reported that the Endowment Committee has met and has re-aligned the investment strategy. We will have 3 categories – Moderate, Aggressive and the Dividends (that are directed to the Operating Church checking account.) We have already seen an increase in the Aggressive category.

Because our Endowment Fund Manager needs specific directions for withdrawals, Wally made the following motion concerning the Endowment Fund usage: In order to pay our monthly expenses, Wesley will harvest all dividends, and then withdraw funds from the Endowment Fund needed to make up the difference to pay our bills as needed and necessary. Bob McKnight seconded. Vote was taken. It was passed unanimously.

The taskforce that has been formed to discover new revenue is investigating a special movie presentation to be offered to the whole community of the Wizard of Oz – with concessions. It will be advertised at the Pride Parade.

# **Apportionment payments**

The Northern Illinois Conference has offered options for paying our Apportionments. Full payment towards the 3 Funds, Support for Ordained Ministry, Mission and Evangelism and Reconnecting the Connection will qualify us to be a 100% church. Paying into the 9% of funds that goes to the General Conference – World Service fund, Ministerial Education Fund, The Episcopal fund, Interdenominational cooperation Fund, Black college Fund, Africa University Fund and General Administration Fund is optional and can be designated if desired. Individuals may also designate their giving to these funds.

The decision was made to support the 3 Annual Conference Funds. Wally Loague requested that we pay our \$54,000.00 in four equal payments - \$10,000.00 per month beginning in August, plus the remaining \$4,000.00 in December. Our special offerings will also go towards apportionment payments, lowering the amounts necessary to be taken from the Endowment Monies.

# Trustees Report

Wally Loague reported that we are moving ahead on our Capital Campaign projects, including the railing and lighting in the Gathering Place and installation of automatic door openers throughout the building. A committee composed of John Klatt, Mary Terrell and Jim Merk will be meeting to discuss and plan the upgrades to sound in the Sanctuary. Thew Elliott will also have input.

# Ministry Areas

<u>Administration</u> – We now have another paying tenant for the building. The Fox Valley Special Recreational Association will be bringing their young adults to have programs in our Chapel 4 days a week.

Jenny Pawlowski has many things to do and oversee. We are very thankful for her efforts. She enjoyed her spa day that we treated her to.

<u>Outreach</u> – Deb Fisher will take charge of Rainbow Covenant area. Kathy Breazeale is still working on finding a time when those who are interested in the Asset Based Community Development can meet. We will publish that we have the books "Having Everything, Possessing Nothing" that people can take from church office. Thew Elliott commented that once we have some models in place, our people will be able to see it in action.

We closed with a Go in Peace Litany.
